Guideline for work in groups

Selected laws (EU, Hungary, Croatia) on regional and local development have to be analysed using the perspective of quality legislation, that is whether the piece of legislation has been properly consulted, evaluated, adopted, published, drafted, formulated, in terms of language, structure etc. in accordance to the principles and rules applicable; examining the possible legal remedies applicable if there are any failure or shortage; making proposals on the possible legislative actions aiming the correction of the laws.
