The course if offered to 4 Croatian and 4 Hungarian students.

ECTS: 4 credits

Brief description

Human right protection is a complex system including national, supranational and international protection interacting regimes. It is even truer by the coming into force of the Charter of Fundamental Rights of the EU as well as the intention of the EU to join the European Convention of Human Rights. It is important for student to be aware of the national (Hungarian and Croatian) human rights procedures in order to apply for the supranational and international bodies. Therefore the course covers the following fields:

- Human rights protection EU: evolution and binding nature of the Charter of Fundamental Rights, its interpretation; joining the ECHR; fundamental rights as the general principles of the EU legal order, common constitutional traditions of Member States; Charter of Fundamental Rights and the relevant case law of the ECtHR.
- Human rights protection international level: i) Origins of human rights protection. United Nations human rights mechanisms: it starts with a theoretical introduction relating to the origins of human rights protection in the international legal system. Afterwards, it concentrates on the human rights mechanisms developed in the UN, with special emphasis on the work of the Human Rights Council as well as that of the core treaty bodies. ii) Human rights protection within the Council of Europe: gives an insight in the conventional system of human rights protection, the one primarily based on the Convention for the Protection of Human Rights and Fundamental Freedoms.
- Human rights protection Croatia; Hungary: it is important for students to be aware of the national human rights procedures in order to apply for the supranational and international bodies.

Classes will be held in the SUMMER SCHOOL, Pécs, 9-15 July 2012, with one-day excursion to Osijek. (See the schedule below.)

- 9. Council of Europe Reform.
- 10. Specific human rights issues within the Council of Europe: Protocol No. 12 general prohibition of discrimination; Minority rights protection; Legal rights for HIV-positive people.
- 11. National constitutional procedure law concerning human rights (Croatia)
- 12. National constitutional procedure law concerning human rights (Hungary)
- 13. Text/evaluation

European criminal law

The course if offered to 4 Croatian and 4 Hungarian students.

ECTS: 4 credits

Course description

The course enhances to the judicial cooperation in criminal matters in the EU. Judicial cooperation in criminal matters is based on the principle of mutual recognition of judgments and judicial decisions by Member States. It involves the approximation of related national laws and the application of common minimum rules. The minimum rules mainly relate to the admissibility of evidence and the rights of crime victims as well as of individuals in criminal procedures. Classes will be held in the SUMMER SCHOOL, Pécs, 9-15 July 2012, with one-day excursion to Osijek. (See the schedule below.)

Environmental Protection in the European Union

ECTS: 4 credits

Brief description

Environmental policy and law is a relative new area of the EU integration; due to its extremely dynamic development, now it plays a central role. The aim of the course is to give an insight into the establishment and development of the EU environmental policy and law, their objectives, principles, and areas for action; furthermore, into the means that are at our disposal and the future possibilities to reconcile economic, social and environmental development. Issues on the right to a clean environment, the EU energy and climate change policy, and the role of the ECJ and of national courts in the development and implementation of the EU environmental law will be discussed. Classes will be held in the SUMMER SCHOOL, Pécs, 9-15 July 2012, with one-day excursion to Osijek. (See the schedule below.)

Teaching method

Teaching activity is performed in the summer school in July 2012 (lecturing in classroom and at excursion).

During spring: students have to read the teaching materials carefully and consult teachers in order to solve the cases with their partners. The papers (1-2 pages long) and the ppt presentation have to be ready by 15 May 2012.

In the summer school: students have to

- attend courses, field studies and social programmes where they can digest the field studies,
- do the "Work in groups" assignments and
- present their cases solved during spring
- make a presentation about "What I have learnt?".
